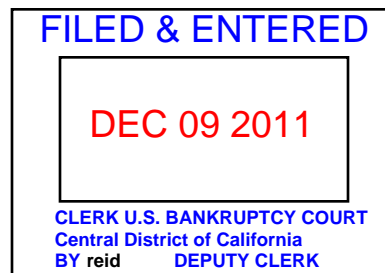

1 On December 6, 2011, at 10:30 a.m., a hearing was held in the above-captioned
2 court on the applications for compensation (collectively, the "Applications") of the following
3 parties (each, an "Applicant"): (1) Development Specialists, Inc. ("DSI"), former
4 consultants for the above-captioned debtors (collectively, the "Debtors") and for Thomas
5 H. Casey, the former chapter 11 trustee and the duly appointed chapter 7 trustee (the
6 "Trustee") [Docket No. 1238]; (2) PGP Valuation, Inc. ("PGP"), appraiser for the Official
7 Committee of Unsecured Creditors (the "Committee") [Docket No. 1095]; (3) Crowe
8 Horwath LLP ("Crowe"), accountants for the Committee [Docket No. 1096]; and (4) Kamal
9 Rajkanan, former Chair of the Committee [Docket No. 1240]. Appearances are as noted
10 in the record.

11 After review of the Applications, the notice of hearing on the Applications [Docket
12 No. 1241], all other papers filed in connection with the Applications, finding that notice and
13 service of the Applications were proper, and having found that good and sufficient cause
14 exists to grant the relief sought by each Application, as modified by the Stipulations (as
15 defined below) and pursuant to the terms and conditions of the Stipulations,

16 **IT IS ORDERED** that:

17 1. The *Stipulation Between Thomas H. Casey, Chapter 7 Trustee, and*
18 *Development Specialists, Inc., Regarding Development Specialists, Inc.'s Final*
19 *Compensation* [Docket No. 1243] (the "DSI Stipulation") is approved, and the terms
20 therein are hereby adopted and incorporated herein in full by this reference as the order of
21 this Court.

22 2. The *Stipulation Between Thomas H. Casey, Chapter 7 Trustee, and PGP*
23 *Valuation, Inc. Regarding PGP Valuation, Inc.'s Final Compensation* [Docket No. 1242]
24 (the "PGP Stipulation") is approved, and the terms therein are hereby adopted and
25 incorporated herein in full by this reference as the order of this Court.

26 3. The *Stipulation Between Thomas H. Casey, Chapter 7 Trustee, and Crowe*
27 *Horwath LLP Regarding Crowe Horwath LLP's Final Compensation* [Docket No. 1245]
28 (the "Crowe Stipulation" and together with the DSI Stipulation and the PGP Stipulation, the

1 "Stipulations") is approved, and the terms therein are hereby adopted and incorporated
2 herein in full by this reference as the order of this Court.

3 4. The Trustee is authorized to execute any documents or take any actions
4 reasonably necessary to effectuate the respective terms of the Stipulations.

5 5. Kamal Rajkanan's chapter 11 costs in the amount of \$485.75 are allowed
6 and approved on a final basis and the Trustee is authorized to pay the allowed amount.

7 6. On the terms and conditions set forth and as provided in the Stipulations, the
8 chapter 11 fees and expenses of each DSI, PGP and Crowe are allowed, approved, and
9 awarded to such Applicant on a final basis in the amounts set forth in the chart
10 immediately below for such Applicant, and the Trustee is authorized to pay the allowed
11 amounts:

5 without further order of the Court, to the extent necessary to (a) pay in full claims allowed
6 by order of the Court that are senior in priority of payment to the Fees and Costs pursuant
7 to 11 U.S.C. § 726, or (b) to achieve a *pro rata* distribution among claims allowed by order
8 of the Court that are equal in priority of payment to the Fees and Costs pursuant to 11
9 U.S.C. § 726.
