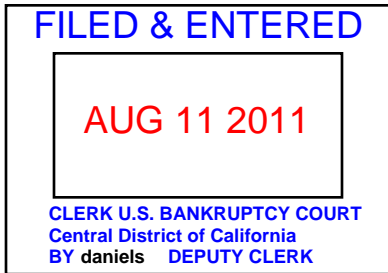

20 deemed appropriate; and having determined that good cause appears for granting the
21 relief requested in the Motion and Supplement,

22 **IT IS HEREBY ORDERED THAT:**

- 23 1. Words and phrases defined or short titled in the Motion or Supplement will
24 have the meaning assigned them in the Motion or Supplement when capitalized and used
25 in this Order.
- 26 2. The Motion, as modified by the Supplement, is granted;
- 27 3. The distribution and payment to VanderSchuit, from the Net Proceeds, of
28 the sum of \$2,521.02, is authorized and approved, and said payment will constitute the

1 full and final satisfaction of any and all claims of VanderSchuit against the Trustee, the
2 Debtor or the Estate, relating to the Majority Action Affidavit or the sale of the Property;

3 4. The set-aside and reserve by the Trustee from the Net Proceeds, for the
4 future payment, subject to the approval and allowance thereof by this Court pursuant to
5 duly noticed fee applications, of the fees and costs of the Trustee and the Trustee's
6 attorneys incurred in connection with the Majority Action Affidavit and the various actions
7 and transactions contemplated therein, including the sale of the Property, the Motion,
8 the Supplement, and the making of the distributions pursuant to this Order, of the sum of
9 \$68,000.00, is authorized and approved;

10 5. The distribution to and retention by the Trustee, from the Net Proceeds, for
11 the benefit of the Estate generally, free and clear of any and all liens, claims or interests,
12 of the sum of \$287,211.20, is authorized and approved;

13 6. The Distribution Schedule, as modified by the Supplement and attached
14 hereto as Exhibit "1", is authorized and approved;

15 7. The distribution to the Junior Lienholders, from the Net Proceeds, pursuant
16 to the Distribution Schedule, of the sum of \$351,035.91, is authorized and approved;

17 8. The distribution and retention of Surplus Funds, as set forth in Section III(D)
18 of the Motion, is authorized and approved;

19 9. The Trustee may substitute, as the payee, with respect to any distribution
20 set forth in the Distribution Schedule, the person who reasonably appears to the Trustee
21 to be the current beneficial owner of the record beneficial interest previously held by the
22 proposed payee identified in the Distribution Schedule if during the process of distributing
23 funds in accordance with the Distribution Schedule: (a) the Trustee is informed that the
24 proposed payee identified in the Distribution Schedule is either deceased or has assigned
25 its subject record beneficial interest, and (b) the Trustee is provided with reasonable
26 evidence of the identity of the current beneficial owner of such interest; and

27 10. The Trustee is authorized to rely on the Debtor's books and records
28 regarding the names and addresses of the Junior Lienholders, and on the information

1 set forth in the Preliminary Title Report and the Supplemental Title Report regarding any
2 assignments of record beneficial interests in the Junior Note and Junior Deed of Trust,
3 and will have no duty or obligation to otherwise attempt to identify or locate any Junior
4 Lienholder.

5 11. This Amended Order cancels and supersedes in its entirety the previously
6 entered "*Order Granting Motion for Order Approving and Authorizing Payment of Certain*
7 *Expenses, Set Aside of Funds for Payment of Anticipated Allowed Fees and Costs, and*
8 *Disbursement of Portion of Remaining Net Sale Proceeds to Junior Lienholders*" entered
9 on August 4, 2011, as Docket No. 1196.
