16 **IT IS ORDERED THAT:**

17 1. The Application is approved and the Trustee is authorized to employ the
18 Firm as his chapter 11 counsel in each of the Debtors' twenty-two jointly administered
19 cases, with the Debtors' estates being jointly and severally liable for such fees and
20 expenses as the Court may hereafter award to the Firm in connection with its
21 representation of the Trustee.

22 2. The terms of the Firm's employment are modified as follows:

- 23 a. The Firm will file interim fee applications every six months; and
24 b. The Trustee shall not be authorized to pay the Firm, pursuant to the
25 modified fee application procedures proposed in the Application,
26 absent further order of the Court.

4. The request that the Court determine that the Debtors' estates are jointly and severally liable for all fees and expenses of the Firm is denied.
